• Mr. Clinton established that enough board members were present to have Quorum for the meeting to proceed.

President's Report

o Mr. Clinton stated that the Northwest Gate Project is almost completed and awaiting the electronic work to be completed. Completion will be sooner than the previous gate project.

New Business:

- **o** Fence Options and materials are currently being reviewed by the ACC.
- O_Mr. Lucky stated that the shadowbox pattern currently approved will be updated and a new pattern and color is in the process of approval to update the durability and look of the community.
- o Mr. Bustamante asked for clarification regarding the color approves and patterns to be utilized. Mr. Lucky stated that Vertical Patterns are preferred to maintain the current aesthetics of the community.
- o Mr. Lucky stated that the current task at hand is to select a compatible pattern.
- o_Mr. Ziemba clarified that the material is Ecofriendly and durable.
- Mr. Clinton stated that the new fence design will be an addition to the currently existing standards.
- o The Architectural Committee will research and provide recommendations for additional companies and materials after approval of vertical pattern approvals.
- <u>o</u> Mr. Fontana stated that the documents do not allow wood fences around the bank of the lake. Clarification needs to be made as to the maintenance of the existing rules.

- Mr. Mulindwa asked for clarification regarding the mixture of materials around the property. Mr. Fontana also clarified that approval for homeowners to have different materials in the property should require a waiver for the installation and change of the fence. - o Mr. Lucky stated that at the present time the selection of the pattern is the principal concern. All subsequent items will be revised after selection and approval.
